BACKGROUND

The Renewable Energy Buyers Vietnam Working Group is co-organized by the <u>Clean Energy Investment Accelerator</u> (CEIA) and the <u>USAID Vietnam Low Emission Energy Program</u> (V-LEEP). Since 2017, the Working Group has brought together commercial and industrial (C&I) energy users interested in procuring clean energy, as well as renewable energy project developers and investors, and Government of Vietnam representatives.

The recurring Working Group is a platform for corporate RE market stakeholders to collectively identify and work toward policy, regulatory and financing frameworks needed to meet clean energy goals in Vietnam.

This four-part webinar series, spread across the last three weeks of May 2020, is an important opportunity to virtually convene market stakeholders during a pivotal phase of Vietnam's clean energy transition.
